- c) Translate symbolically. Use the same letters for each proposition.

i. If Martha is sick then either Carol is with Martha or Jenny is with Martha.

- ii. Carol is with Martha if and only if Martha is sick and Jenny is not with Martha.
- iii. It is not the case that if Carol is with Martha then Jenny is not with Martha. (3)
