



DISSERTATION GUIDELINES

The following are intended for guidelines purposes only and they may vary among departments.

1. General Framework of the Dissertation

2. Dissertation Format

Length

B.A. Hons	15,000 - 18,000 words
M.A. (by research)	50,000
M.A. (taught)	25,000
M.Phil.	50,000
Ph.D.	100,000

Excluding of Abstract, References, Appendices and Bibliography but inclusive of Tables and Figures.

Format

Layout should strictly follow the guidelines available from the *Step by Step Guide to Create a User-Friendly Electronic Dissertation* accessible from this link <https://www.um.edu.mt/library/etd/etdstudents>

For more detailed information students are advised to read carefully the style sheet available on their departmental website.

Pages should normally be double-sided (except the preliminary 5 pages which must be single-sided).

3. Plagiarism

Plagiarism refers to the act of copying other people's work and presenting it as one's own. This is nothing short than theft of intellectual property, and is to be condemned in the strongest terms possible. Students caught plagiarizing will be severely penalized. 4. Submission

B.A. Hons students must submit their dissertation within the deadline indicated by the department.

In the case of M.A./M.Phil/Ph.D. students must submit their work according to the end date as indicated on sims.

Extensions of the deadline are granted only for valid reasons after obtaining the approval of the supervisor and Head of Department and with the approval of the Faculty Board of Arts and Senate in the case of M.Phil. and Ph.D. candidates.

5. Number of Copies

Together with the soft-bound copies, students are to submit to the departmental secretary the following forms. The Authenticity form with no details is the one which should be included in the dissertation which is eventually uploaded on Hydi. The other one is for official purposes only.

B.A. Hons 3 soft-bound copies (spiral bound) together with a CD

M.A. 5 soft-bound copies (spiral bound) together with a CD
(The number of copies requested may vary across departments)

M.Phil./Ph.D 6 soft-bound copies (spiral bound)

Students are to submit their thesis for examination to Ms Nadette Xuereb in Rm 113, Guze Cassar Pullicino Building.

6. Dissertation Examination

Dissertations are examined by a number of examiners including the external examiner.

7. Vivas

Once the dissertation/thesis is submitted, the secretary will ensure that copies are provided to your examiners, in advance of your viva examination. The departmental secretary will contact the student regarding the date of the viva-voce examination.

When the viva has taken place students are normally informed of the outcome by the Chairman of the Board of Examiners. Students may be asked to do some minor corrections before submitting the final copies and being awarded the degree.

If major changes have to be effected, the dissertation/thesis will be referred back to the student and he/she will be notified by the Faculty Manager or by the Chair of the Board of further procedures which would need to be taken.

8. Hard-Bound Copies

Some departments no longer require a hard-bound copy of the dissertation, but it is advisable that students contact the departmental secretary for further information.

A soft copy for the University Library should be submitted to the departmental secretary.

In case of M.Phil. students, 3 hard-bound copies and a soft copy are to be submitted to Ms Nadette Xuereb in Rm 113, Guze Cassar Pullicino Building and in case of Ph.D. students, 4 hard-bound copies and a soft copy are to be submitted to Ms Nadette Xuereb in Rm 113, Guze Cassar Pullicino Building.

It is very important that students submit a digital copy to the University Library. Regulation 85 of the General Undergraduate Awards, 2019 states that:

“A student in debt to the University, or otherwise having unfulfilled obligations to the University, shall not be permitted to re-register in any succeeding sessions, nor shall a degree, higher diploma, diploma or certificate be conferred upon a student in debt or having unfulfilled obligations, except by special permission of the Rector, or until the debt is paid or the obligation is fulfilled”.

The Registrar will be notified if any CD is not submitted by the stipulated date indicated by the departmental secretary.

9. Final Classification Result

The Final Result will be published on your e-sims portal.
