### **NUR5131 Advanced Nursing Management of Critically III Patients**

**10 ECTS Credits** 

This study-unit is primarily intended for qualified nurses who work in critical care areas and who are expected to assess, manage and care for critically ill patients and their relatives.

**Available for:** Qualified Nurses with a minimum of a level 6 qualification and who hold a registration as a first level nurse with the Council for Nurses and Midwives or a regulatory body recognised by the UM. Interested applicants who are not in possession of a level 6 qualification in nursing / health science are encouraged to contact the study-unit coordinator / CPD courses administrator. Limited to 20 students.

CPD study-unit fee: €400

Practising health care professionals who are interested in enrolling on these study-units are invited to apply between **Thursday 26 October and Friday 24 November. DEADLINE EXTENDED TILL 7 DECEMBER.** Applications may be submitted here. Applicants ought to submit their application as **NEW USERS**.

All applications will be considered on a first come first served basis. Applicants can apply for not more than 30 ECTS credits per semester or up to a maximum of three study-units per academic year if the study-units are part of a full programme.
